"Powerful Schools; Powerful Purpose: Assumptions, Struggles, and Promises to Keep"

Description: Not for the faint hearted; a provocative analysis of the real achievement, economic, and citizenship gap in America and what students, faculty, parents, and community members can do to deliver on the promise of public education. The conventional wisdom about schools, education, curriculum, technology, economic stratification, and student achievement must be replaced with a deeper understanding of the role of education, the capacity of educators, and ways of intellectually challenging all students to connect learning to an ever changing future and a revitalized democratic society for all.

Carl Glickman has just returned to The College of Education at The University of Georgia as "Scholar in Residence" in the new graduate program in Educational Administration in the Department of Lifelong Education, Administration, and Policy. This highly focused PHD and Master's degree program will prepare a new generation of outstanding school leaders, scholars, and policy researchers

Glickman will teach, advise, and collaborate with faculty and students on various initiatives related to the public purpose of education. Just prior to his return to UGA, he held the first Endowed Chair in Education at Texas State University -San Marcos.

His career at Georgia began in 1979 and in 1997, he was awarded the University Professorship, the highest faculty career award of the University of Georgia for bringing, "stature and distinction" to the mission of the University. Students also honored him as the faculty member who had "contributed most to their lives, inside and outside the classroom." He was Founder and Chair of the nationally validated University of Georgia League of Professional Schools that partnered with hundreds of schools and districts throughout Georgia for the past fifteen years in providing a democratic education for all future citizens.

He is the author of thirteen books on school leadership, educational renewal, and the moral imperative of education. Leadership for learning was recognized by the National Association of Education Publishers as one of the four outstanding education books of 2002. His 2003 book, <u>Holding sacred ground; Leadership, courage, and endurance in our Schools</u> was acclaimed as one of the most important writings in education today. His edited book, <u>Letters to the next</u> <u>President; what we can do about the real crisis in public education</u> was chosen by <u>Foreword</u> <u>Magazine</u> as one of the two most outstanding books in education for the year 2004. His co-authored textbook on Super-Vision and Instructional Leadership with Steve Gordon and Jovita Ross -Gordon is in its sixth edition and remains a leading text in the field.

Glickman currently is working on a book for parents on how to choose and improve their child's school and is collaborating with University and public school colleagues at local, state, and national levels in how to center educational practices and policies on the public purpose of education. Carl is a founding member of the national policy center entitled The Forum for Education and Democracy ((www.forumforeducation.org) and has served on the boards of Kids Voting U.S.A. and the National Commission for Service-Learning.
