County Excellence Submission Guidelines

DEADLINE: FRIDAY, JANUARY 12, 2024

Nominations for the Georgia County Excellence Awards Program must include:

- Completed Application Form
- Program/Initiative Description
- 2–3 High Resolution Digital Photographs (at least 300 dpi)
- Up to two (2) Supplemental Attachments (see below for more information on supplemental attachments)

PROGRAM/INITIATIVE DESCRIPTION

The program/initiative description may not exceed four double-spaced pages in length and must address the following items:

30 Brief summary of the program/initiative, including:

- Main purpose and goals

- How and when it was developed and implemented
- Cost of the program and how it is financed
- Staffing

40 What is the current and expected future impact of the program/initiative (include specific results)?

- 3. How is the program/initiative innovative? Does it apply new methods, techniques, or procedures that are not commonly used?
- 4. Are citizens, community groups, or other governmental entities, nonprofit organizations or businesses involved in its development and implementation?
- 5. Can the program/initiative be adapted and replicated in other counties?

SUPPLEMENTAL ATTACHMENTS

Eligibility Standards & Selection Criteria

In an effort to ensure counties of all sizes are considered and recognized, applicants are asked to identify the population category to their to which their county belongs. Please see the nomination form for the population category breakdown.

ELIGIBILITY STANDARDS

- Any county in the state is eligible to submit an awards application.
- award per year.
- into the population category of the largest county within the program/initiative.
- elected official i.e., county chair, CEO, or mayor of a consolidated government.
- The application must demonstrate that county officials and/or staff had a vested involvement in developing and implementing the program/initiative.

SELECTION CRITERIA

An independent panel of judges will score applications based on the six criteria for a maximum of 100 points.

(Criteria 1: Up to 5 points can be awarded for each objective met for a maximum of 25 points)

- 1. The program/initiative meets one or more of the following objectives:
- Improves the quality or the administration of county programs
- · Addresses important problems and/or meets specific needs in the community
- Offers improved services to county residents
- Enhances the overall community quality of life
- Can be adapted or replicated in other counties

(Criteria 2–6: Will be scored on a scale of 1 to 15 (for a maximum of 75 points))

- 2. The program/initiative was cost effective and/or utilized creative funding sources.
- 3. The program/initiative is innovative and applies new methods, techniques or procedures that are not commonly used.

AWARD DESIGNATIONS

• Individual counties may submit a maximum of two (2) applications each year. When possible, counties are encouraged to combine several projects into one application. A county is eligible for only one

• A county may submit a regional program for consideration that includes multiple counties within one program/initiative. For the purpose of the population designation, the regional program will be placed

• Any county elected or appointed official may submit the application with the signature of the chief
