DR. KENNETH STEIN, EMORY UNIVERSITY

"The Long and the Short of the Arab Upheavals: the Impact on the US and the Middle East"

r. Kenneth W. Stein is the William E. Schatten Professor of Contemporary Middle Eastern History, Political Science and Israeli Studies at Emory University in Atlanta, Georgia.

Stein has numerous publications. His scholarly contributions have focused on American foreign policy, inter-Arab politics, the Arab-Israeli conflict and the negotiating process. His publications have appeared in Arabic, French, German, Hebrew and Spanish. He has taught courses focusing on the Middle East in the 20th Century, American Foreign Policy toward the region, the Arab-Israeli conflict, Palestinian social history, and modern Israel.

Stein is a frequent contributor to the national and international media. For three years, 1980-1983 he was moderator of a Georgia Public Television program, World in Review. He is the recipient of the highest awards at Emory for internationalizing the curriculum, life-long student mentorship, and excellence in undergraduate teaching. He is the founding Director of the Emory Institute for the Study of Modern Israel.

Stein received his BA degree from Franklin and Marshall College, Masters in Middle Eastern History and Near Eastern Literatures and Languages, and a doctorate in modern Middle Eastern History from The University of Michigan. He studied at The Hebrew University of Jerusalem and began his academic career at Emory in January 1977.

Stein and his wife Lynn have three daughters-in-law, three sons, and two grandsons.

"Elbert Parr Tuttle: Chief Jurist of the Civil Rights Revolution"

nne Emanuel is a 1975 graduate of Emory Law School. She clerked for Judge Tuttle; practiced law with Huie, Brown & Ide (which represented MARTA); and clerked for Chief Justice Harold N. Hill of the Georgia Supreme Court before joining the faculty of the Georgia State University College of Law in 1986. From 2004 to 2006 she served as Associate Dean for Academic Affairs

Professor Emanuel is a member of the American Law Institute. She was the Reporter for the Georgia Trust Act of 1991, and the chair of Georgia's ABA Death Penalty Moratorium Implementation Committee. She has also served on the Board of the Federal Defenders, Inc. for the Northern District of Georgia; of GreenLaw; of the Atlanta Bar Association; and on the Formal Advisory Opinion Board of the State Bar of Georgia.

The University of Georgia Press published her biography about Judge Tuttle in October 2011.
