# Federal Legislative Update

As I sit and write this update, the U.S. Senate is considering S3101 – the "Medicare Improvement for Patients and Providers Act of 2008". Without approval of this bill, massive Medicare cuts will go into effect July 1, 2008. This includes a 10.6% cut on July 1, 2008 and a cut in excess of 5% on January 1, 2009. S3101 is a bipartisan bill that prevents implementation of cuts for 18 months and provides ODs with positive payment updates through December 31, 2009. Well, I don't know about y'all, but I know MY costs sure aren't going down! The AOA has been a leading voice on Capitol Hill in support of Medicare payment fix legislation.

In other federal legislative news, HR 1884, a bill that would end the exclusion of optometry in the National Health Service Corps, picked up an additional 35 cosponsors as a result of our lobbying. HR 1983, the Optometric Equity Act, has 61 cosponsors. We need more! Ophthalmology is against this legislation (obviously!) and it will be reintroduced next year. I'll be asking for y'all to help me on that one! Finally, HR 507 and the companion S1117, the Children's Vision Bill, is not moving in the Senate.

Now, time for a big thank you! AOA-PAC crossed the big \$1.5 million mark! We are now the fourth largest healthcare PAC. The top three are the AMA, the ADA, and Radiology. As you may know, the AMA is really going after non-MD providers. This summer AOA-PAC will start another campaign stressing the need to combat what Medicine is saying. Please contribute if you have not done so already. I hope these updates show the importance of keeping our legislative relationships strong.

I will have brochures and AOA-PAC information available at the Summer Seminar. Hope to see you there!

### **In Memoriam**

**Dr. J. Marcus Smith,** a retired optometrist, 82, died Friday, May 16, 2008, at his home surrounded by family after a short illness. He was born December 27, 1925, in Florence, SC, a son of the late Marcus Redding and Geneva Neal Ross Smith of Conway, SC. His loving wife of fifty-four years, Frances Marian Johnson Smith and his sister, Hannah Darden, both predeceased him.

Dr. Smith graduated from Conway High School in 1942 and went to the University of South Carolina for one year before going to Southern College of Optometry in Memphis, TN. He graduated from Southern College of Optometry in 1946, but was too young to legally open a practice, so he worked in Columbia for one year before moving to Myrtle Beach in 1947 and opened his optometry practice, where he was the first eye doctor in Myrtle Beach.

Dr. Smith married his childhood sweetheart October 7, 1950, in Conway. Dr. Smith was active in the Myrtle Beach Jaycees. He was the 1957 Jaycees Young Man of the Year. He was also very active in leading the youth program (MYF) of First United Methodist Church in Myrtle Beach for many years. Dr. Smith was a contributing writer on local history for the *Sun News*. Survivors include three sons, J. Marcus "Marc" Smith, Jr., Dr. Franklin N. Smith and David Ross Smith.
