President's Message: WE ARE...SCOPA!

What is SCOPA, some of you may be wondering. SCOPA stands for "South Carolina Optometric Physician Association". Yes, you read it right. By virtue of our training, licensure, scope of practice, we ARE Optometric Physicians. Optometry schools are calling student doctors "Optometric Physicians". Their level of competency is increasing every year and they are given the charge by their professors to refer to themselves as such as they go out into practice. There are six states that now refer to their Association and themselves as Optometric Physicians; Alaska, Idaho (their practice act refers to them as physicians), Washington State, Oregon (they had reimbursement issues and that was one of the main reasons they changed), Oklahoma, and New Jersey. Pennsylvania is currently investigating this issue and Florida has it already established in their law. Our state board has ruled that we can call ourselves Optometric Physicians and we certainly practice optometric medicine.

This issue was discussed at planning board '07 and it was determined to further investigate our Association's use of the words "Optometric Physician". Medicare on a national level has designated us as physicians. The AOA is fighting for us to get Medicaid to classify us as physicians as there is potential legislation that would lock us out of Medicaid reimbursements due to currently not being listed as physicians. Nationally, there is talk of establishing more "medical home" models that would have patient access controlled by physicians. We ARE the primary eyecare physician and we need to make sure that we continue to be. Part of that equation is how we refer to ourselves to the medical community, our patient base, and to the payor industry. We are healers, through refractive/optical means, vision therapy, treatment of ocular disease, and treatment and management of ocular manifestations of systemic disease. Our profession has evolved and so should the name of our profession to keep up with the level of how we practice. That is not to say we are not proud of our "roots" but just as some of our colleagues were against using diagnostics, then some of us were against using therapeutics, change is sometimes uncomfortable for some. Let that not stop you from looking at this with an open mind and understand that this could actually turn into a reimbursement issue which will affect most of our livelihoods if we are not PROACTIVE versus being REACTIVE.

I ask that you think long and hard, discuss among yourselves, discuss with your executive committee members, and then I ask you to join me in being PROACTIVE and continue to lead our Association in the 21st century and beyond and rename our association to the "SOUTH CAROLINA OPTOMETRIC PHYSICIAN ASSOCIATION". I want to thank Lori Donovan for her contributions in research on this issue. Regards, Peter

Special Olympics-Opening Eyes Using Our Optometric Talents to Give Back to the Community By: Jennie Smith, O.D.

The Special Olympic Mid-Winter Games were held at the Citadel in Charleston on March 7-9, 2008. As part of the Healthy Athlete Program, Optometrists joined together at the Opening Eyes Screening to provide vision care to the athletes.

The mission of Special Olympics/Lions Club International Opening Eyes Program is to improve the quality of life for the millions of individuals diagnosed with intellectual disabilities by through quality eye care. The objectives of Opening Eyes include: 1. providing screenings to Special Olympics athletes, 2. educating athletes, parents, and coaches of eye care professionals about the vision care needs of persons with intellectual disabilities worldwide, and 3. increasing knowledge of visual and eye health needs of persons with intellectual disabilities through research. Past research conducted with the athletes at Special Olympics events has revealed that 68 percent have not had an eye examination in three years, 37 percent needed glasses, and 18 percent of the athletes were wearing clinically incorrect glasses. The generous support of the Opening Eyes Partners enables Special Olympics to reach and assist more members of one of the world's most underserved population, those with intellectual disabilities. Opening Eyes Partners include: Lions Club International, Essilor (provide all of the lenses), Luxottica Group (provide designer frames and sunglasses), Liberty (provide sports goggles), and Santinelli International (provide edgers.) The Opening Eyes program is represented in all 50 states and worldwide! Anywhere you find the Special Olympics you will find the Opening Eyes Program. The screenings include visual acuity, color testing, stereo vision, cover testing, pupil

testing, anterior and posterior health of the eye, intraocular pressure measurement, refraction and, if needed, a complete pair of glasses and/or sports goggles are made at no cost to the athletes or their families.

On March 8th, optometrists, Lions Club members, opticians, and optometric assistants united to make the Charleston Mid-Winter Games Opening Eyes an AMAZING success! 61 athletes were screened, 34 pairs of glasses and 10 pairs of goggles were made, and 4 athletes were referred out to optometrists from their local areas. SC Opening Eyes Clinical Directors Dr. Jennifer Smith and Dr. Michael Zolman organized and planned the event. Optometrists that participated in the screening were Dr. Greg Bailey, Dr. Lori Donovan, Dr. Keith Farley, Dr. Rahul Gupta, Dr. Jeff Magun, Dr. Jennifer Smith, and Dr. Michael Zolman.

The next SC Opening Eyes event will be held at the Special Olympic Summer Games in Fort Jackson, SC on May 3, 2008. SCOA PAC and Legislative Update

Federal Legislative Update

In April, Drs. Ed Lemon, James Vaught, Lori Donovan and I will attend the AOA Congressional Conference in Washington, DC. This is a fantastic opportunity for us to meet with our South Carolina Senators and Representatives and talk with them about bills and issues affecting optometry. These major bills include:

HR1983 – The Optometric Equity in Medicaid Act. This bill provides for an update to the Medicaid law by applying the Medicare definition of a physician, which includes optometrists. This bill would confirm to state government bureaucrats and Medicaid third party payers that optometrists are fully able to provide medical eye care services to Medicaid patients. We need more Congressional co-sponsors.

HR2012 – Contact Lens Consumer Health Protection Act. This bill would immediately strengthen contact lens prescription verification requirements on Internet and mail order sellers and address the use by a large seller or automated "rob-calls" into doctors' offices.

HR507/S1117 Vision Care for Kids Act. This legislation would establish a Federal grant program aimed at bolstering states' children's vision initiatives. Currently, this bill will not be given priority consideration on Capitol Hill unless a sufficient number of cosponsors are added. The only South Carolina co-sponsor is Rep. Jim Clyburn.

So folks, maybe this will give you an insight into the importance of supporting optometry at all levels. As for AOA-Pac, South Carolina contributions continue to come in but we still have a long way to go. To contribute online, go to www.aoa.org, click on the advocacy tab, and follow the link to AOA-PAC or send me your information and I'll do it for you. It's just that easy.
